

# Membership Subscription Terms and Conditions

This website is operated by Uniti General Trading "UGT", license number CN-3661578. Throughout the site, the terms "we", "us" and "our" refer to UGT. UGT offers this website, including all information, tools and services available from this site to you, the user, conditioned upon your acceptance of all terms, conditions, policies and notices stated here.

These Terms and Conditions for Membership Subscription and Services ("General Conditions") are effective from the Effective Date by and between Daleelx.com operated by Uniti General Trading ("UGT"), a company registered in United Arab Emirates (license number CN-3661578), ("UGT") and your company ("Client"), as governed by the United Arab Emirates laws. Any purchase, dispute or claim arising out of or in connection with this website shall be governed and construed in accordance with the laws of UAE. Unless otherwise agreed by the Parties in writing, these General Conditions, and any Service Request executed hereunder shall govern UGT provision of the Products and Services to the Client (collectively, the "Agreement"). The parties hereto may be referred to individually as a "Party" or collectively as the "Parties". If you are entering into this agreement on behalf of a company or other legal entity, you represent that you have the authority to bind such entity to the terms and conditions of this agreement. In consideration of the mutual promises herein made, and for other good and valuable consideration, the sufficiency and receipt of which is hereby acknowledged, the Parties agree as follows:

- 1. Definitions. When used in the Agreement, the following capitalized terms shall have the following meanings:
  - a. "AFFILIATE" means in relation to a Party, any entity which directly or indirectly controls, is controlled by, or is under common control with that Party. For purposes of this definition, the term "control" (including the terms "controlled by" and "under common control with") means the power to direct or cause the direction of the management and policies of a Party (whether by contract or otherwise), or contacts associated to that Party. Notwithstanding the foregoing, all service requests requested on UGT website available at http://www.daleelx.com/en/services shall be deemed to be "Affiliates" of UGT.
  - b. "UGT CONTENT" means all software, data, text, images, audio, video, photographs and other content and material, in any format, that are obtained or derived from our



- c. platforms (that Clients may access through, within, or in conjunction with the use of the Membership Subscription Services. Examples of UGT Content include, but are not limited all content used in, Documentation, Instagram, snapchat, website, connectors, or otherwise stated source.
- d. "DELIVERABLE" means tangible or intangible result of Services provided to Client pursuant to a Service Request.
- e. "SERVICE REQUEST FORM" means UGT's standard order form (or other similar document duly executed by the Parties) entered into pursuant to this Agreement which specifies the Subscription Services, Products and/or Services to be ordered by Clients hereunder, and the fees therefor.
- f. "SERVICE REQUEST" means collectively the Service Request Form(s).
- g. "SUBSCRIPTION SERVICES" means with respect to the Service Request the subscription services provided by UGT within the UGT Managed Environment or for Clients request and use in the Client Managed Environment, as specified in the applicable Service Request and this Agreement
- h. "SUBSCRIPTION TERM" means the period identified in the applicable Service Request during which UGT is required to provide Client with Membership Subscription Services. Subscription Term includes Initial Subscription Term together with any Renewal Terms, as defined herein. "Any purchase, dispute or claim arising out of or in connection with this website shall be governed and construed in accordance with the laws of UAE"
- i. "THIRD PARTY CONTENT" means all software, data, text, images, audio, video, photographs and other content and material, in any format, that are obtained or derived from third party sources outside of UGT that Client may access through, within, or in conjunction with the use of the Subscription Services. Third Party Content includes third-party sourced materials accessed or obtained by using the Subscription Services or any tools provided by UGT platforms. In addition, any purchase, dispute, or claim arising out of or in connection with this website shall be governed and construed in accordance with the laws of UAE
- 2. Access; Use; Ownership; Restrictions
  - a. Rights granted. UGT hereby grants Client, for the applicable Membership Subscription Term and subject to the terms and conditions of this Agreement and the applicable Service Request(s), a limited, non-exclusive, non-transferable, non-



sublicensable, irrevocable (except as otherwise set forth herein)

right to use the Subscription Services, up to the applicable Usage Metric(s), for Clients internal business purposes only. UGT Subscription Services are provided in accordance with applicable Documentation and relevant Service Requests. UGT may modify the Subscription Services and its Documentation from time to time provided, however, such modification shall not result in any material degradation of the Subscription Services provided to Client during the then-current Subscription Term. The Membership Subscription Services and any Products/Services may contain or rely upon Third Party Content licensed to UGT under commercial or open-source agreements. Clients right to use such Third-Party Content are governed by the terms of any associated license agreement specified by UGT or the Third Party, and not under this Agreement. Cardholder must retain a copy of transaction records and www.Daleelx.com policies and rules

b. Ownership. UGT shall retain all right, title and interest (including, without limitation, all patent, copyright, trademark, trade secret and other intellectual property rights) in and to the Products, Membership Subscription Services, UGT Content and Documentation and all copies thereof. Client is granted no rights in the Products, Subscription Services, UGT Content and Documentation other than those limited rights expressly set forth herein and in the relevant Ordering Documents. All right, title, and interest to the Retained Works shall remain with UGT. As used herein, "Retained Works" shall mean: (i) any pre-existing materials, intellectual property, methodology, or know-how, including any of UGT Content, UGT pre-existing software code, proprietary software tools, or training materials incorporated into the Deliverables; (ii) any modifications or enhancements or additions to any pre-existing materials discovered or reduced to practice in performance under the applicable SOW not specifically created for Client; and (iii) any Third-Party Content which are integrated with or incorporated into the Deliverables. Except for "Retained Works", all right and title to Deliverables exclusively and explicitly created by UGT for Client pursuant to the Professional Services shall vest in the Client upon full payment for such Deliverables. UGT grants Client a perpetual, royalty-free and non-exclusive license to use and modify the Deliverables (and any Retained Works incorporated therein) for its internal use only, subject to any other express supplemental license terms otherwise applicable to the Deliverable, and to make a reasonable number of copies of the Deliverables for internal use.



- 3. Membership Fees and Payments:
  - a. Subscription Fees: The subscription fees for our membership services will be clearly stated during the subscription process. By subscribing, you agree to pay the specified fees.
  - b. Payment Method: You must provide a valid payment method for your membership subscription. By providing your payment details, you authorize us to charge the subscription fees at the specified intervals.
- 4. Confidentiality
  - a. Employees, volunteers, and board members of [UGT] may be exposed to information which is confidential and/or privileged and proprietary in nature. It is the policy of [UGT] that such information must be kept confidential both during and after employment or volunteer service. Employees, staff, including board members, are expected to return materials obtaining privileged or confidential information at the time of separation from employment or expiration of service.
  - b. Unauthorized disclosure of confidential or privileged information is a serious violation of this policy and will subject the person(s) who made the unauthorized disclosure to appropriate discipline, including removal/dismissal.
  - c. It is the policy of [UGT] that all employees, business partners, of [UGT] will not disclose confidential information belonging to, or obtained through their affiliation with, [UGT] to any person, including their relatives, friends, and business and professional associates, unless [UGT] has authorized disclosure. This policy is not intended to prevent disclosure where disclosure is required by law.
  - d. Confidentiality is the preservation of privileged information. [UGT] Employees and partners are cautioned to demonstrate professionalism, good judgment, and care at all times in handling any information related to [UGT] to avoid unauthorized or improper disclosures of confidential information.
  - e. User is responsible for maintaining the confidentiality of his account
- 5. Code of Ethics
  - a. [UGT] is diligent in offering you with the best service possible by creating a social community and providing its members with a supportive and non-discriminatory community. Consequently, it's imperative that we abide to the following guideline to avoid any violations:



- Creating non ethical competing behaviours [against UGT or it's members]
- Controversial content [including revealing or unacceptable behaviours foreign to UAE laws]
- Treat others with dignity and respect at all times. [including UGT's employees]
- Avoid slang or idioms that might not translate across cultures. Criticizing other's religions, nationalities, races, personal preferences, or any similar discriminatory behaviours
- [UGT] will not tolerate discrimination, harassment or any behaviour or language that is abusive, offensive, or unwelcome.
- 6. Violation Policy
  - a. In accordance with our efforts to provide you with the best service possible, we have a violation system to protect all parties involved. It's imperative to keep in mind that breaching any of the Codes of Ethics, not obliging to agreement terms or being disrespectful or difficult towards [UGT] employees or partners will be considered violations. Under these circumstances, violations can lead to temporary bans, termination and legal actions might follow.
- 7. Membership Duration and Cancellation Policy

- 9. Privacy

- a. All clients are expected to submit work that they've done. UGT won't be held responsible for any fraudulent activities.
- 11. Payments, Fees & Registration process

After members sign up and create an account, they will be asked to choose the suitable membership type and go through the onboarding process. At checkout, they will be asked to pay the registration fees and can then submit their membership - refundable, and the membership fees will only be deducted upon approval. Members will received their invoices and all relevant information via the email used for the membership. Processing time takes from 2 - 3 working days.

Daleelx.com collects:

The following data is collected by or on behalf of Daleelx.com :

- 1. Data provided by users. This includes:
- User profile: We collect data when users create or update their Daleelx.com accounts. This may include their name, email, phone number, login name and password, address, profile picture, payment or banking information (including related payment verification information), government identification documents, including driver's license numbers and images, birthdate, signature, and photo. For more information, please see the section titled "How we use personal data."
- Demographic data: We may collect demographic data about users, including through user surveys.
- User content: We collect the information users submit when they contact Daleelx.com customer support, provide ratings or compliments for other users or partners, or otherwise contact Daleelx.com. This may include feedback, photographs or other recordings collected by users.
- 2. Data created during use of our services. This includes:

- In connection with legal proceedings

Daleelx.com does not sell or share user personal data with third parties for their direct marketing, except with users' consent.

Daleelx.com uses the data it collects for purposes including:

This includes using the data to:

### E. Data retention and deletion

Daleelx.com may also retain certain information if necessary for purposes of safety, security, and fraud prevention. For example, if Daleelx.com deactivates a user's account because of



unsafe behavior or security incidents, Daleelx.com may retain certain information about that account to prevent that user from opening a new Daleelx.com account in the future.

## F. Grounds for processing

We only collect and use personal data where we have lawful grounds to do so. These include processing user personal data to provide requested services and features, for purposes of Daleelx.com's legitimate interests or those of other parties, to fulfill our legal obligations, or based on consent.

We collect and use personal data only where we have one or more lawful grounds for doing so. Such grounds may vary depending on where our users are located, but generally include processing personal data:

A.To provide requested services and features

In order to provide our services, we must collect and use certain personal data. This includes:

- Transaction information
- Information relating to customer support

B.For purposes of the legitimate interests of Daleelx.com or other parties

This includes using personal data to maintain and enhance our users' safety and security. For example, we use personal data to prevent use of our services by users who have engaged in inappropriate or dangerous behavior, such as by retaining data of banned users to prevent

their use of Daleelx.com's apps. We also use usage data to prevent matching of riders and drivers for whom there is higher risk of conflict (for instance, because they have been the subject of prior complaints from other users).

This also includes purposes such as combating fraud; improving our services, direct marketing, research, and development; and enforcing Daleelx.com's Terms of Service.



In addition, it includes using personal data to the extent necessary for the interests of other people or the general public, such as in connection with legal or insurance claims, and to protect the rights and safety of others.

C.To fulfill Daleelx.com's legal obligations

- We collect and use personal data to comply with such laws.
- Daleelx.com may also share data with law enforcement regarding criminal acts or threats to public safety, or requests by third parties pursuant to legal processes.

D.With consent

- Daleelx.com may collect and use personal data based on the user's consent. For example, we may collect personal data through voluntary surveys. Responses to such surveys are collected on the basis of consent and will be deleted once no longer necessary for the purposes collected.
- A user who has provided consent to a collection or use of their personal data can revoke it at any time. However, the user will not be able to use any service or feature that requires collection or use of that personal data.

Choice and transparency

Daleelx.com enables users to access and control the data that Daleelx.com collects, including through:

- In-website settings
- Device permissions
- In-website ratings pages
- Marketing opt-outs

Daleelx.com also enables users to request access to or copies of their data, changes or updates to their accounts, deletion of their accounts, or that Daleelx.com restrict its processing of user personal data.



## A. Privacy settings

Settings menus in the Daleelx.com website to give them the ability to set or update their information preferences and their preferences for receiving mobile notifications from Daleelx.com. Information about these settings, how to set or change these settings, and the effect of turning off these settings is described below.

Daleelx.com provides users with service status notifications and updates related to activity on their account. These notifications are a necessary part of using the Daleelx.com website and cannot be disabled. However, users may choose the method by which they receive these notifications through the Settings > Privacy menus in the Daleelx.com app.

• Notifications: discounts and news

Users may enable Daleelx.com to send push notifications about discounts and news from Daleelx.com. Push notifications may be enabled or disabled through the Settings > Privacy menus in the Daleelx.com app.

#### B. Device permissions

Most mobile device platforms (iOS, Android, etc.) have defined certain types of device data that apps cannot access without the device owner's permission, and these platforms have different methods for how that permission can be obtained. iOS devices notify users the first time the Daleelx.com website requests permission to access certain types of data and gives users the option to grant or refuse permission. Android devices notify users of the permissions that the Daleelx.com website seeks before their first use of the app, and use of the website constitutes a grant of such permission.

#### D. Marketing opt-outs

Users may opt out of receiving promotional emails from Daleelx.com here. Users may also opt out of receiving emails and other messages from Daleelx.com by following the unsubscribe instructions in those messages. We may still send users who have opted out non-promotional communications, such as receipts for rides or information about their account.



#### User data protection rights

Daleelx.com provides users with a variety of rights that can be exercised to learn about, control, and submit questions and comments about Daleelx.com's handling of their data. If you wish to exercise any of the data protection rights set out below, please contact us at info@daleelx.com.

- Accessing data: Users can ask for an explanation of the data we collect from them and how we use it.
- Receiving data: Users can ask for a copy of data that Daleelx.com collects from them with their consent or as necessary to provide our services.
- Changing or updating data: Users can edit the name, phone number, email address, payment method, and photo associated with their account through the Settings menu in Daleelx.com 's apps or driver portal. They may also ask that Daleelx.com change or update their data, including if they believe such data is inaccurate or incomplete.
- Deleting data: Users may request deletion of their account at any time through through Daleelx.com 's website or by reaching to our customer support number.
- Objections, restrictions, and complaints: Users may request that we stop using all or some of their personal data, or that we limit our use of their data.Daleelx.com may continue to process data after such objection or request to the extent required or permitted by law.

### International transfers:

Where your personal data is being transferred to countries outside the UAE either by us or by third party service providers acting on our behalf, UGT will ensure that those transfers are adequately protected, by putting in place the necessary organisational and technical measures, and guarantee the lawful processing of your personal information in accordance with the relevant law.

We have put in place appropriate security measures to prevent your personal data from being accidentally lost, used or accessed in an unauthorized way, altered or disclosed. In addition, we limit access to your personal data to those employees, agents, contractors and other third parties who have a business need to know. They will only process your personal data on our instructions and they are subject to a duty of confidentiality.



Updates to this notice

We may occasionally update this notice. Use of our services after an update constitutes consent to the updated notice to the extent permitted by law.

We may occasionally update this notice. If we make significant changes, we will notify users in advance of the changes through the Daleelx.com apps or through other means, such as email. We encourage users to periodically review this notice for the latest information on our privacy practices.
